The Mayor and Council of the City of Franklin met in Regular Session on Tuesday, May 21, 2024, at 6:00 PM at City Hall, 300 Iberia Street, Franklin, Louisiana. Mayor Eugene P. Foulcard called the meeting to order. Also present were Councilmembers Chuck Autin, Joseph Garrison, Lester Levine, and Jaime Robison, and City Clerk Karen LeBlanc. Absent were Councilmembers Larry Guilbeau and City Attorney Russel J. Cremaldi.

The invocation was offered by Mayor Foulcard and Councilman Garrison led everyone in the Pledge of Allegiance.

Mr. Ed Jones, representing the 100 Black Men of St. Mary Parish, promoted the 4th Annual Soul Food Festival to be held on June 14-15, 2024.

Mrs. Ella Hamilton, Franklin resident, requested that the Council make changes to the Home Rule Charter; to include how many meetings a council person could miss during their service and to also make sure the person is living in their district.

MAYOR'S EXECUTIVE REPORT:

Mayor Foulcard presented his report. He thanked the Downtown Merchants for hosting Dinner Under the Lampposts and expressed the economic impact on such events. He thanked the Crossing Place for the various events they have been conducting for the children and also thanked the organizers of Sunday Funday in the Park.

Mayor Foulcard stated that Cayce Street project is nearing completion. The project addressed the collapsing street, drainage issues, and sewer issues.

Mayor Foulcard stated that due to the HVAC system not being complete at Broussard-Harris Recreation Center the kids at that center will be bussed to McKerall-Oniel Recreation Center for the Summer Feeding Program.

DEPARTMENTAL REPORTS:

Police Chief Cedric Handy gave a report of the successes during his first year as chief. He thanked the community for their cooperation and tips that have led to the arrest of several suspects. He boasted a 42% decrease in felony crimes in Franklin. Staffing of officers has increased from 10 to 24. He has reestablished relationships with the District Attorney's Office, the Sheriff's Office, other departments within the parish, and the School Board. Chief Handy stated that there is still a long way to go but he believes the foundation has been laid.

Mayor Foulcard stated that the March 2024 Financial Statement was presented to the Council.
