## MAYOR'S EXECUTIVE REPORT:

Mayor Foulcard presented the following report. At the end of August a delegation of the City Council, members of my administrative team including myself attended the Louisiana Municipal Association Conference held in Shreveport. Besides attending educational classes as well as recertification and informative sessions we attend the gala that includes the LMA Community Achievement Awards. Once again I would like to announce that the City of Franklin was awarded the statewide Community Achievement Award for Outstanding Community Improvement in Technology & Creativity for the Historic Downtown Franklin Pocket Park Mural Project. This project was made possible by the Louisiana Division of the Arts, Percent for Art Program, Atchafalaya National Heritage Area, City of Franklin with contributions by Mr. Al Kuhlman and the Kuhlman family and Bargain Barn Too. This project within the Pocket Park will help create a direct economic and tourism impact for the City and our merchants by increasing foot traffic and tax revenues in our beautiful city.

So as our revitalization movement continues to grow we must still find other grants and funding sources to keep the momentum of revitalizing our city's infrastructure and city services. The council and myself have been discussing each and every option that our community faces with our CFO, Mr. Ed Hay, and weighing against each and every infrastructure need within our city. Although since this administration has taken office we have begun the process of rehabbing our water distribution system by leveraging any and all option available through Federal, State and Local monies available. Thankfully, Senator Bret Allain and State Representative Vinney St. Blanc allocated Capital Outlay funding in the amount of \$2.4 million dollars, however, with that said we are unlikely to receive the full amount of funds needed so we must try other avenues.

A large portion of city budget goes to cover expenses for safety and security of our city for fire and police protection. As you can imagine the costs of a ladder and tanker fire unit or police unit and equipment can be astronomical. Although both units get as much grant funding as possible through their own grant writers the council will look to address this coverage of costs through vote for a percent sales tax for both police and fire Municipalities may utilize increase in property tax or percent of sales tax to build large sports complexes that only serve a small percentage of their community. However, putting a price on safety and security as well as helping to alleviate years of neglected replacement of our City's water distribution lines is something myself and this council feel our community will get behind as we see the need and hear the complaints of our constituents. Again, we don't get millions or billions of dollars in free foreign aid and whatever grant money's we do receive the City must put up at least a 25% match. I, along with the Council, feel this is a must to helping our city address our aging 100 year old water distribution lines by freeing up funds for the Police and Fire Departments through the City budget. Know that what impacts your family also impacts ours. Councilmembers Garrison, Rack, and expressed gratitude for being able to attend the LMA conference. It offers opportunity for education and networking with other communities.

Councilman Garrison was recognized at the LMA Conference for serving six consecutive terms in office.

Councilwoman Rack, Chairwoman of the Education Committee, expressed interest in calling an Education Committee meeting in the near future.

Chris Barrilleaux, Recreation Director, gave a report on summer recreation and feeding program.

Chief Cedric Handy discussed the juvenile curfew, school zones, and laws related to motorized bicycles and gulf carts on city streets.
