## MAYOR'S EXECUTIVE REPORT:

Mayor Foulcard presented his report. He thanked the citizens of Franklin for their overwhelming support of the police and fire 1% sales & use tax during this past election cycle. The tax will allow us to better serve and protect those that work so hard to protect and keep our community safe.

Mayor Foulcard thanked each and every family that took part in all the Christmas activities this season to help make lasting family memories at home. He stated that these events truly make Franklin the most beautiful and charming city. He thanked the City of Franklin's Public Works Department led by Mr. Jeremy Smith and Ms. Belva Notto for their hard work into transforming our beautiful city into a Hallmark movie.

Mayor Foulcard stated that citizens are tampering with water meters. He mentioned that there is an ordinance on the books that prohibits tampering of the meters. He warned that the customer will be responsible for the meter if damage is done. Customers should call City Hall if they are having issues with their meter.

Mayor Foulcard stated that he continues to work with the State of Louisiana, our Legislative Delegation and the Louisiana Department of Health in an effort to have the Boil Notice rescinded. We continue to work hard each and every day to rehab our 100 year old water distribution system and 60 year old water plant. He stated that the engineering phase rehab work on the water plant will begin in the New Year utilizing the \$2.4 million dollars allocated from State Capital Outlay funds from Senator Allain and State Representative St. Blanc. The New Year after grinding will also bring a complete rehab to Northwest Blvd.

He wished everyone a safe, happy, healthy and Merry Christmas on behalf of the City Council, City Employees, himself and his family.
